WHY?		Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. We are committed to protecting your privacy. Your personal data is collected and used solely for the purposes described in this policy. Your data will not be transferred to external organizations under any circumstances. We implement appropriate measures to ensure the security and confidentiality of your information. Please read this notice carefully to understand what we do.			
WHAT?		<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"><li>▪ Address and phone number</li><li>▪ Social security number</li><li>▪ Assets</li><li>▪ Risk tolerance</li><li>▪ Wire transfer instructions</li><li>▪ Transaction history</li></ul> <p>When you are no longer our customer, we continue to retain information about you in accordance with SEC regulations.</p>

Why can't I limit all sharing?		<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"><li>▪ sharing for affiliates’ everyday business purposes—information about your creditworthiness</li><li>▪ affiliates from using your information to market to you</li><li>▪ sharing for nonaffiliates to market to you</li></ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>			
Definitions					
Affiliates		<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><li>▪ <i>Our affiliates include companies such as Toth &amp; Associates, Inc.</i></li></ul>			
Nonaffiliates		<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><li>▪ <i>Toth Financial does not share with nonaffiliates so they can market to you.</i></li></ul>			
Joint Marketing		<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"><li>▪ <i>Toth Financial does not jointly market.</i></li></ul>
